The objective of this MOU is mutual benefit to the student and faculty members of both the colleges with academic information sharing, collaborative research, skill development, training and quality improvement.

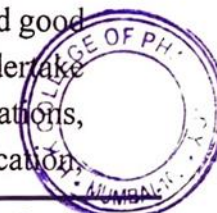



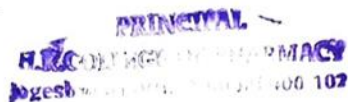
