

## **MEMORANDUM OF UNDERSTANDING**

This Memorandum of Understanding (MoU) is entered into on this 28th day of March 2025, by and between:

### **1.0 Preamble:**

**3.0. Terms and Conditions:**

- III. Both parties agree to maintain confidentiality concerning any proprietary or sensitive information shared during this collaboration.
- IV. Payment to INTELLEX shall be made in advance before commencement of any work/assignment as per payment conditions mentioned on the quotation (annexed herewith as Annexure -1) herewith and invoices generated from time to time, approval of quotation shall be communicated by email before commencement of every project.

**4.0. General Provisions:**

- I. Any disputes arising out of this MoU will be resolved amicably through mutual consultation.
- II. Either party may terminate this MoU with a 30-day written notice to the other party, provided that ongoing activities will be concluded as per agreed terms.
- III. This Memorandum of Understanding will become effective upon signing of this agreement by the representatives from both the parties.
