TERMS OF UNDERSTANDING:

a) **Commitment from Maharashtra Educational Society's H.K. College of Pharmacy**

Ready to support WeGo Library in increasing awareness & adoption of the WeGo Library research Program by effective communications to the Principals/Professors/Students of member colleges /institutions and use of library resources and use of WeGo library resources for research and joint research activities.

b) **Commitment from WeGo Library Foundation**

The research support program will cover the following aspects: Creating Research environment and ecosystem, Cultivating Reading culture and offering collection of books, journals and e-resources, use of library resources, Idea to Lab, incubating Grant & Supports through patent journey and voluntary mentoring for patent process. Joint research activities for rejuvenating Indian sciences and its applied derivatives. Intent is also to make available ready technical research for entrepreneurs to make world class product through innovation. Interpersonal Skills, Start-up, and Entrepreneurship.

WeGo will not have any right on invention claimed in Patent applied with help of WeGo.

WeGo will sign and maintain confidentiality agreement.



Maharashtra Educational Society's H.K.College of Pharmacy and Patentee may apply to patent with any other agency (other than WeGo) at any time and have complete right on the IPR and its outcomes.

WeGo will help to Institute by offering support in terms of Lawyers and Counsellors and sponsoring patent filling expenses.

c) Joint Commitment by both parties

Lectures by experts, Joint research activities, co-incubation of Start-ups, joint product development program, Entrepreneurship development program, mentorship programs, Facilitation of translational research, Bootcamps for Students, Student projects, Exchange of members for technical – administrative staff for skill enhancement, Participation of seminars and academic meetings, Exchange of students and staff for the purpose of Knowledge sharing, training of students and staff with respect to advance technology.



Duration:


This MOU shall be valid from the Effective Date and shall remain in force for 10(Ten) years from the effective date, unless terminated earlier by either Party as provided herein below. Either party may terminate this MOU by giving three (3) months' notice to the other party, on termination, each party shall return to the other party all such confidential and proprietary information, documents and reference material of the other party in its possession. All such obligations and terms of the MOU that are required to survive the termination of this MOU shall survive such termination.

Maharashtra Educational Society's H. K. College of Pharmacy leveraging the scope outlined in this MOU for its students and professors will be doing so under the then prevailing terms and conditions of WeGo Library research Hub.





