  - Aug-Sept: Introduction to Clinical research (CR) field Seminar.
  - Sept-Oct: Interpersonal Skills.
  - Oct-Nov: Aptitude Test Preparation & Aptitude Test towards CR field.
  - Dec-Jan: Poster Presentation competition in CR field.
  - Feb-Mar: Mock Interviews about CR field.
  - Apr-May: Final Counselling.
- 2. The cost for the above programs will be borne by MITCON.
- 3. Stationery materials will be arranged by MITCON.
- 4. The schedule with dates shall be provided by MITCON in consultation with the concerned person nominated by the H. K. College of Pharmacy. MITCON will nominate a dedicated resource to implement the training.
- 5. MITCON will arrange necessary items like travel, lunch, and other requirements for faculties at the H. K. College of Pharmacy. Certificates will be arranged by MITCON after the delivery of all workshops to eligible students.
- 6. This is not a placement drive. Hence, no direct placement is provided by MITCON
- 7. Said program is towards bringing awareness on Clinical Research (CR) to interested students.

### · H. K. College of Pharmacy:

- 1. Provide appropriate space to conduct workshops with necessary equipment like mike/ screen/ dais/ sitting arrangement etc.
- 2. Nominate a dedicated resource to coordinate the training.
- 3. Arrange infrastructure like IT and non-IT support.
- 4. Arrange a batch of Second, Third and final-year B. Pharm / M. Pharm. students.
- 5. The strength of the batch may vary and will be agreed upon after discussion with the Head of the Biotechnology Department, MITCON Pune.
- 6. Ensure attendance of students, as the program is philanthropic work by MITCON & hence MITCON does not expect any charges against such programs.
