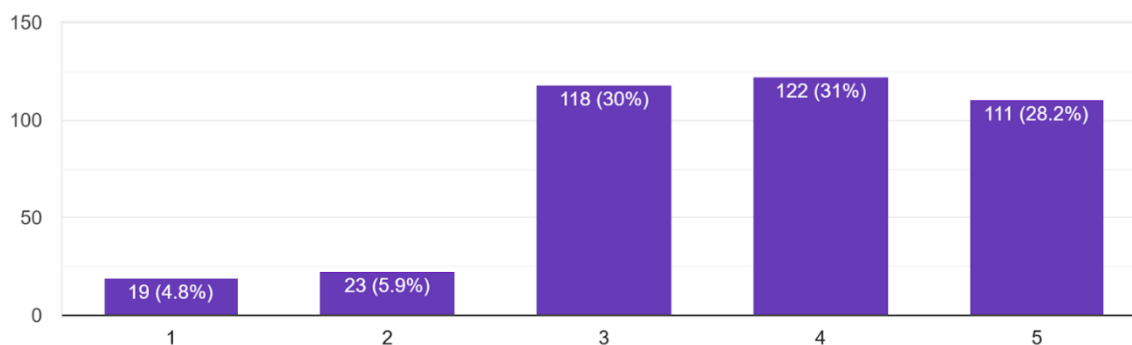

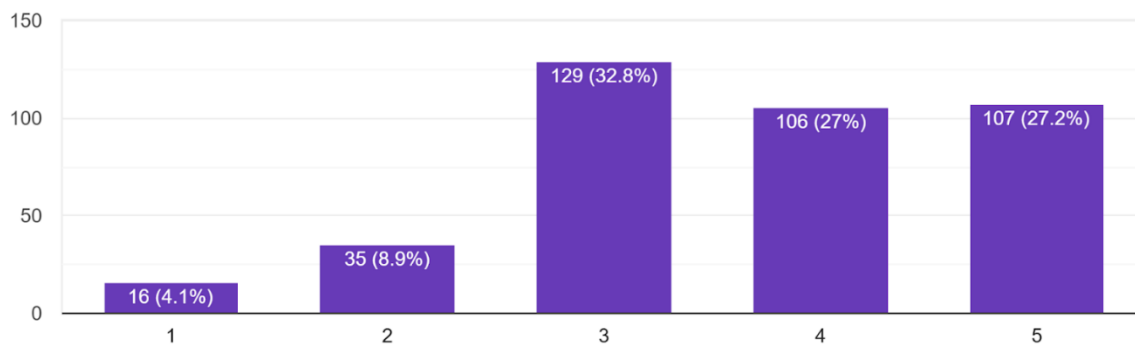

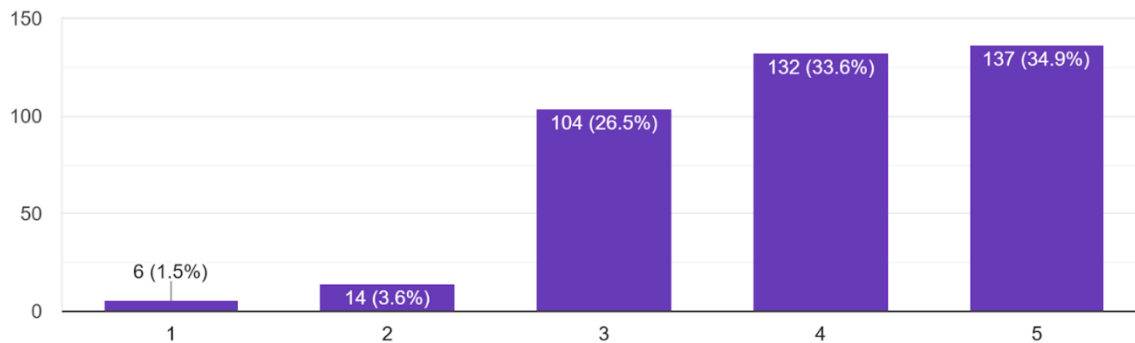

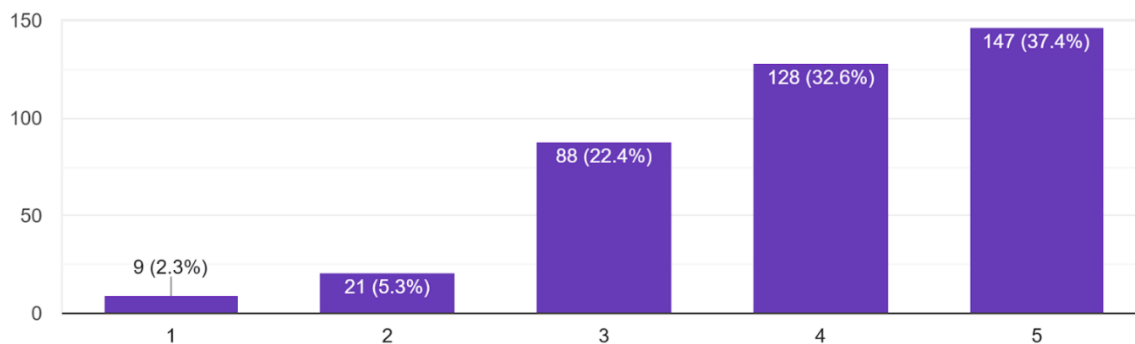

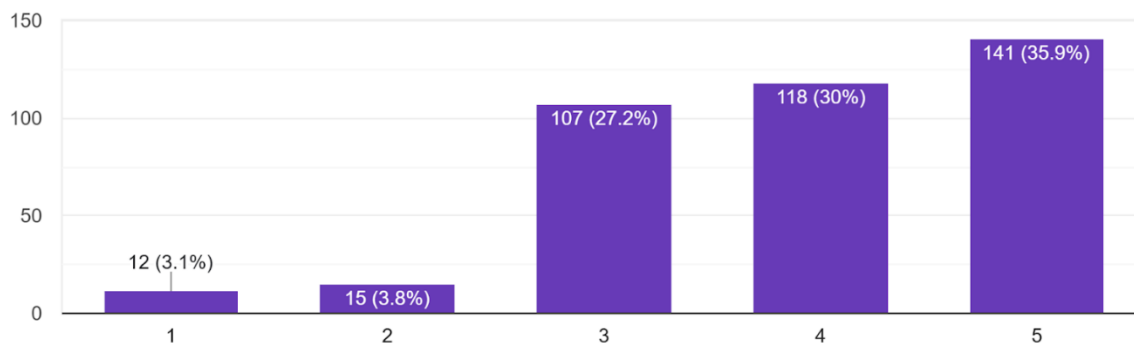

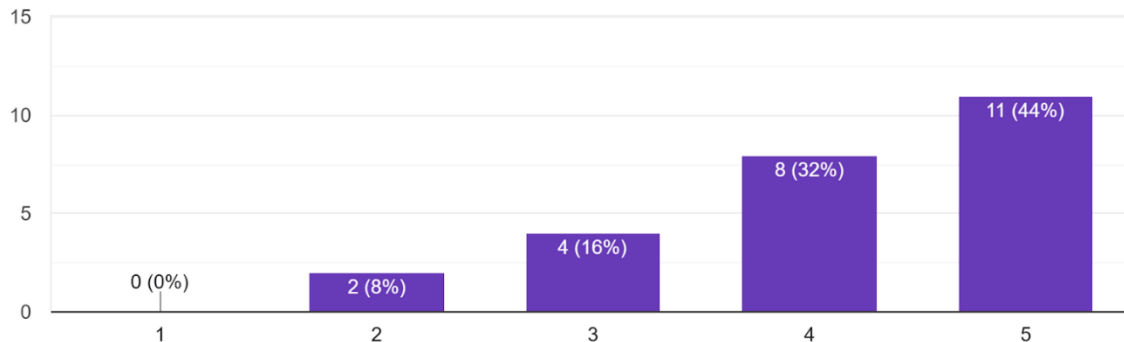

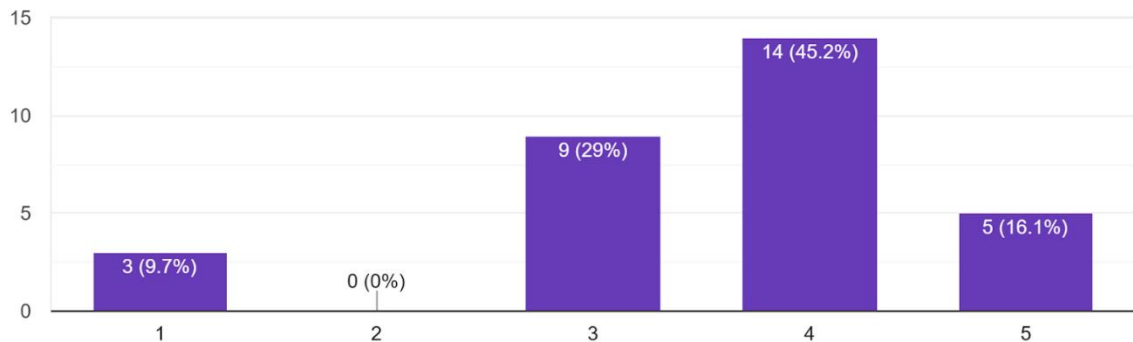

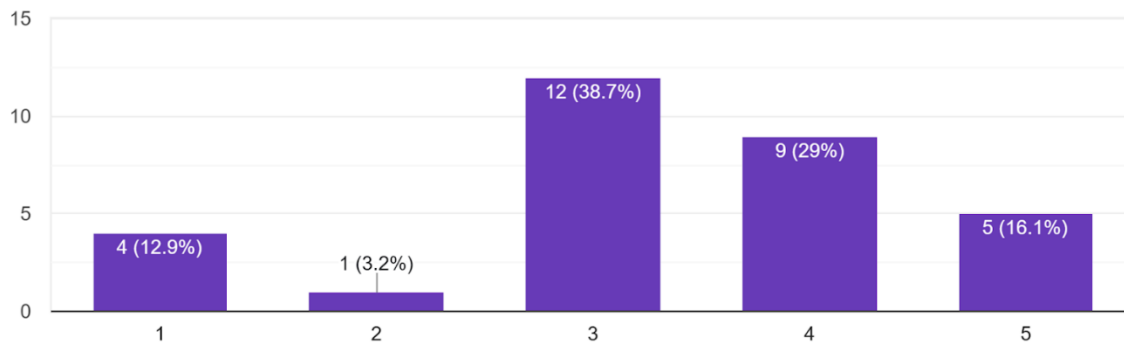

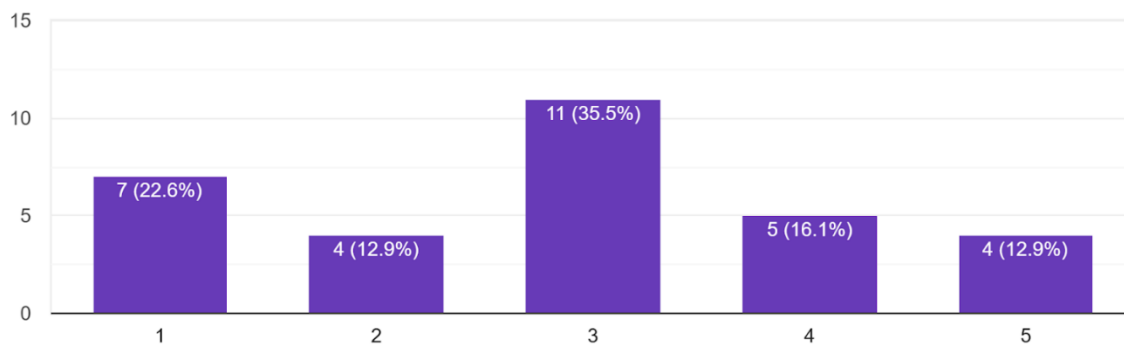

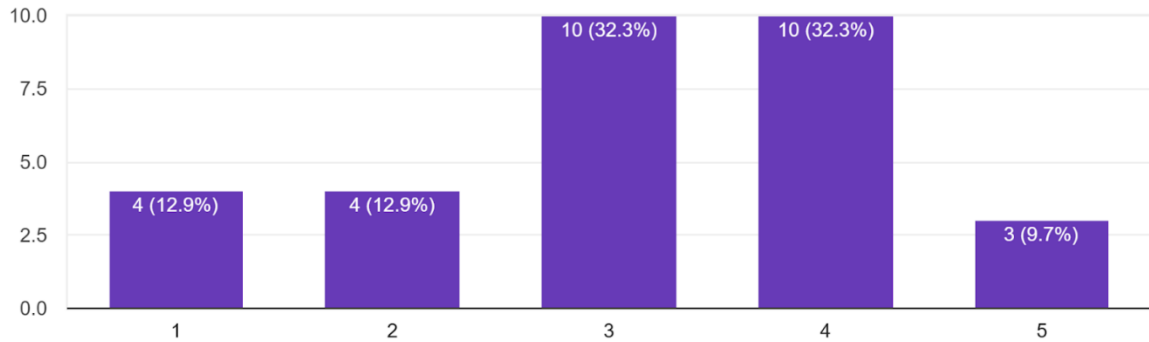

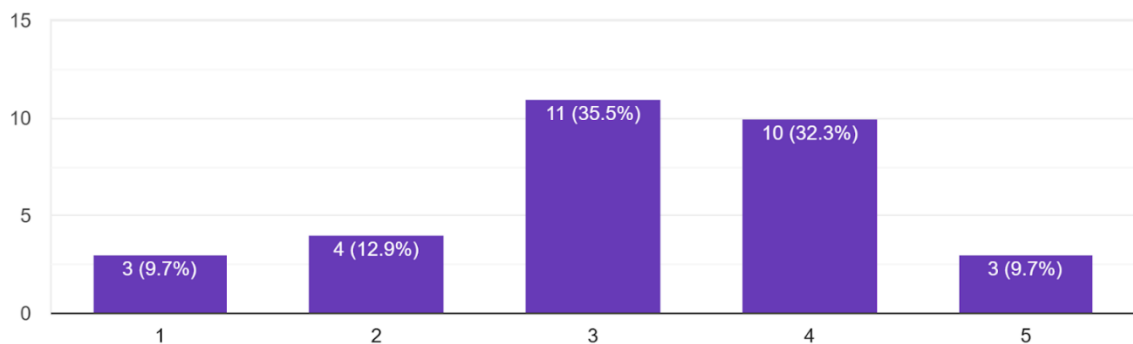

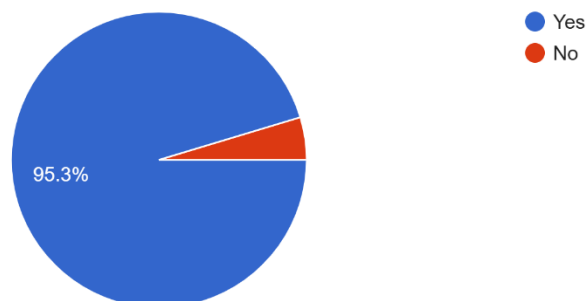

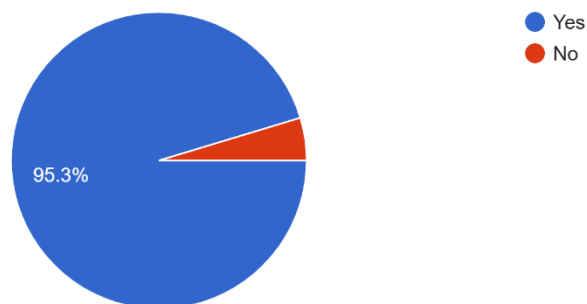
Do you feel that your ward is secured in the campus

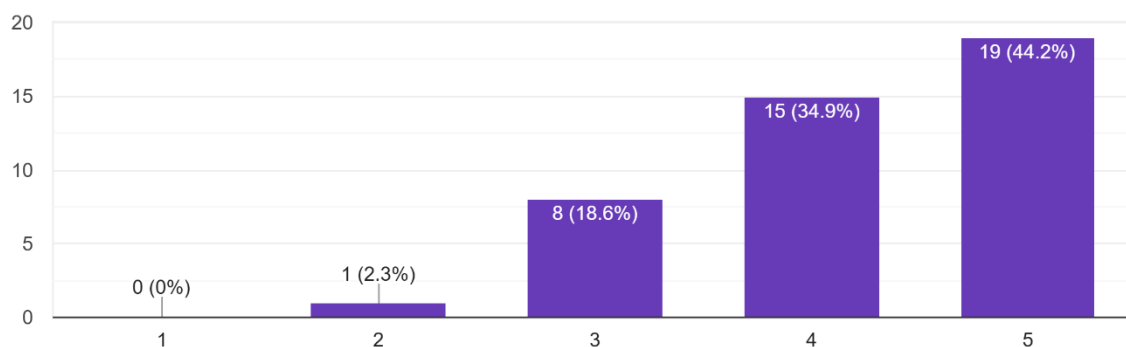
